Cansu has a keen interest in Court of Protection work. Cansu has a particular interest in cases involving personal injury and clinical negligence claims. These often involve children who have cerebral palsy where an independent Deputy is required to deal with a multi-million pound settlement. In these cases Cansu works closely with litigation solicitors, case managers, occupational therapists, physiotherapists and other experts to ensure that her clients day to day life runs smoothly. We also have several cases where the partners of the firm are Attorneys for clients under registered Lasting Powers of Attorney. Cansu also assists with the day to day management of these clients.

abuse was in the region of £1 million. The result was that the solicitor was struck off by the SRA.
